Dear Representatives Schakowsky and King:

The Leadership Council of Aging Organizations (LCAO) is a coalition of 69 national nonprofit organizations concerned with the well-being of America's older population and committed to representing their interests in the policy-making arena. The undersigned members of the LCAO are pleased to support the Advancing Connectivity during the Coronavirus to Ensure Support for Seniors Act (ACCESS Act, H.R. 6487).

Thank you for your bipartisan leadership to improve access to virtual visitation for nursing home residents and their families during this pandemic. The health and safety of people living in nursing homes is vital. While in-person visitation is restricted, it is essential for residents to have the ability to visit virtually and communicate with their loved ones. Also, expanding telehealth in nursing homes can increase access to care during the COVID-19 pandemic and assist with efficient use of staff, which is especially critical.

The ACCESS Act would provide grants to nursing homes to support virtual visits and require participating facilities to ensure residents can access these visits. The grants would be used for obtaining and using technologies and services necessary to support such visits during the current public health emergency and would help enable more residents and their loved ones to stay connected, including being able to see each other via video. Such communication would help mitigate social isolation and loneliness for residents, which can have a significant impact not only on their mental health and well-being, but also on their physical health and well-being. In addition, virtual visits would provide much-needed reassurance for families, many of whom are very anxious about the well-being of their loved ones.

Moreover, the legislation would provide funding to the Telehealth Resource Center Program to help enable the development of telehealth technologies for nursing homes. Finally, your bill would require a report to Congress on ways to expand access to telehealth in Medicare- and Medicaid-certified nursing homes during the pandemic.

Thank you for your commitment to expand access to virtual visitation and telehealth. Residents and families would truly benefit from virtual visits during this challenging time. We look forward to working with you and your colleagues to help make this a reality for more residents and their loved ones.
